Judges Draw by number Single & Pair Skating/Ice Dance for the Winter Youth Olympic Games 2024 – Gangwon/KOR

The draw by number for the above-mentioned event was held on October 21, 2023 on the occasion of the ISU Grand Prix of Figure Skating® 2023 Humana Skate America in Allen, TX / USA.

The draw took place in the Judges Room in the presence of Ms. Patricia St. Peter, ISU Council Member, Mr. Wieland Lüders, ISU Event Manager Figure Skating, Mr. Hirohiko Saso, ISU Assistant Event Manager Figure Skating, as well as GP Skate America Event Delegate Members from CAN, GEO, GER, JPN, KOR and SWE.

Judges marked with P1 are Judges coming from the Pair Skating panel. Judges marked with M1 are Judges coming from the Men panel. Judges marked with W1 are Judges coming from the Women panel. The Judge must be the same for the Pair Skating panel and for the Men or Women panel. Four Alternate Judges (who are not on site) have been drawn for Men, Women and Ice Dance. If a Judge in Pair

Skating needs to be replaced, the replacement Judge will come from the Alternate list of the Single Events.

Should there be a withdrawal of a Judge which cannot be replaced by any of the Alternate Judges, the replacement Judge will be drawn amongst all Judges present in Gangwon, available and qualified for the discipline concerned but not represented already in the concerned panel. This will complete the panel to the possible maximum number of nine (9) Judges.

Judges entries by name (including Alternates) must be sent by the drawn ISU Members by e-mail to the ISU Secretariat (entries@isu.ch) with a copy to the NOC of the respective Member by latest **October 30, 2023**.

Judges must have the qualification of "ISU Judge".

Members drawn for the two Single events (Men and Women) may enter two Judges. Members drawn for one Single event (Men or Women) and the Pair Skating event can only enter one Judge. Members drawn for the Ice Dance event may enter an additional Judge in addition to those Judges entered for the Single & Pair Skating events.

For each Judge's entry within the limits outlined above, the drawn ISU Members may nominate a substitute Judge.

Alternate Judges will not be present on site unless one of the entered Judges would withdraw and the Member of that Judge has not entered a substitute Judge by name. Only in this case the alternate Judge(s) in the order of the draw result will be called on site. The Alternate Judges will be released 7 days before the start of the Winter Youth Olympic Games 2024.

The maximum period of presence for the Judges is as follows:

Arrival: January 25, 2024
Departure: February 2, 2024
